I. The Meeting was called to Order at 6:00 PM by Mayor Kirby

II. Invocation and Pledges of Allegiance led by Mayor Kirby

III. Citizens Comments – No action can be taken.

Council to discuss and take action to approve an Ordinance canvassing the returns and declaring the results of the City of Pattison General Election conducted on May 2, 2026. **Councilmember Buller made a motion to approve the canvass and results of the City of Pattison General Election in which Daphney Kirby was elected Mayor, Lee Kosina was elected for Councilmember Position No. 1 and Charlie Keel was elected for Councilmember Position No. 2. Councilmember McGowan seconded the motion. Passed unanimously. Councilmember Lee Kosina then took her place on Dias and was present for the remainder of the meeting. Charlie Keel passed away after the election but before the canvass creating a vacancy in Councilmember Position No. 2.**
3. Mayor and Council to recognize departing councilmembers and hear comments from same. **Mayor Kirby presented departing councilmember, Frank Cobio with an award on behalf of the City of Pattison for his years of service. Former Councilmember, Joe Garcia, was not present and thus unable to receive his award during the meeting. No action.**
4. City Engineer to present updates on City projects. **Craig Kalkomey presented City project updates. A report is expected from LJA at the June City Council Meeting to include updates regarding the FMA Master Drainage Plan. No action.**
5. Council to discuss and take possible action to award or reject bids for a construction contract for Pattison Drainage Project, TXCDBG Contract #CDV23-0302, in Pattison, within Waller County, Texas. **Councilmember Buller made a motion to approve the award of a contract to Craig & Heidt, not to exceed \$284,726.70 and to be completed within 45 days. Councilmember McGowan seconded the motion. Passed unanimously.**
6. Council to discuss and take possible action on a City Procurement and Purchasing Policy. **Councilmember McGowan made a motion to accept and approve the proposed City Procurement and Purchasing Policy. Councilmember Flowers seconded the motion. Passed unanimously.**
7. Council to discuss and take possible action on November 2026 City Council Meeting Date **Councilmember McGowan made a motion to amend the November 2026 City Council Meeting Date to November 19th, 2026. Councilmember Flowers seconded the motion. Passed unanimously.**

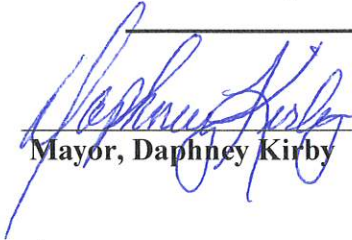

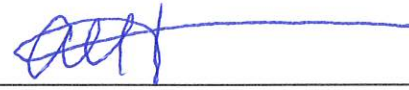
