ORDINANCE NO. 37

AN ORDINANCE ADOPTING AND ACCEPTING THE PROVISIONS OF CHAPTER 1 TO 10, TITLE 28, OF THE REVISED CIVIL STATUTES OF TEXAS, 1925, RELATING TO CITIES AND TOWNS.

WHEREAS, the City Council of the Town of Pattison is desirous of adopting and accepting the provisions of Chapter 1 to 10, Title 28, of the Revised Civil Statutes of Texas, relating to cities and towns; and

WHEREAS, the Town of Pattison contains one or more manufacturing establishments (namely: HDH Instruments, Inc., 3166 FM-359 and Lone Star Machine Shop, 3402 1st St.) within the corporate limits, now therefore;

BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF PATTISON, TEXAS:

Section 1. The provisions of Chapter 1 to 10, Title 28, of the Revised Civil Statutes of Texas, 1925, relating to cities and towns, is hereby adopted and accepted.

Section 2. The City Secretary of the Town of Pattison, be directed to enter this ordinance upon the journal of minutes of the City Council, and a copy of same signed by the Mayor and attested by the City Secretary under the Corporation Seal shall be filed and recorded in the office of the County Clerk of Waller County, Texas.

Section 3. That this ordinance shall take effect immediately upon its recording in the office of the County Clerk.

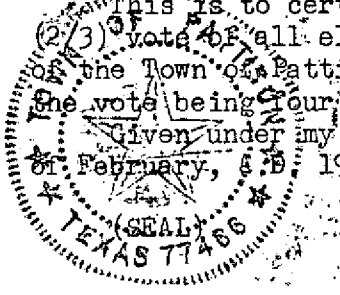

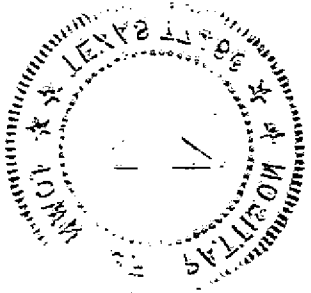
