

AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO A FIRE PROTECTION SERVICES CONTRACT WITH THE PATTISON AREA VOLUNTEER FIRE DEPARTMENT, INCORPORATED PROVIDING FOR SERVICES TO BE RENDERED, CONSIDERATION TO BE PAID, AMENDMENT OF BUDGET AND ALLOCATION OF RESOURCES, SEVERABILITY, EFFECTIVE DATE, PUBLISHING AND POSTING.

WHEREAS, it is in the best interest of the community to support emergency fire protection services serving the City of Pattison, Texas; and

WHEREAS, the PATTISON AREA VOLUNTEER FIRE DEPARTMENT has recently organized and is seeking to acquire a fire truck and equipment and has requested funds from the City of Pattison.

WHEREAS, providing for fire services is in the public interest.

All findings recited herein are found to be true.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PATTISON, TEXAS:

I.

1. The Mayor is hereby authorized to enter into a Fire Protection Services Contract on the terms and conditions described in Exhibit "A" attached hereto and made a part hereof.
2. The budget is hereby amended and the Mayor is authorized to allocate such resources and funds necessary to implement this Agreement.
3. The City agrees to pay the PATTISON AREA VOLUNTEER FIRE DEPARTMENT INCORPORATED the sum of THIRTY THOUSAND AND NO/100 (\$30,000.00) DOLLARS.
4. The City Council has adopted this Ordinance and related matters in order to protect health, life, and property and to preserve the good government, order and security of the City of Pattison and its residents.

III.

This Ordinance shall take effect from and after the date of its passage and all Ordinances or portion of Ordinances heretofore passed in conflict with the terms hereof are specifically repealed.

IV.

If any provision, section, subsection, sentence, clause, phrase of this Ordinance, or the application of same to any person or set of circumstances is for any reason held to be unconstitutional, void or invalid, the validity of the remaining portions of this Ordinance or their application to other persons or sets of circumstances shall not be affected thereby, it being the intent of the City Council in adopting this Ordinance that no portion thereof or provision, or regulation contained herein, shall become inoperative or fail by reason of any unconstitutionality of any other portion hereof and all provisions of this Ordinance are declared to be severable for that purpose.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PATTISON, TEXAS:

I.

1. The Mayor is hereby authorized to enter into a Fire Protection Services Contract on the terms and conditions described in Exhibit "A" attached hereto and made a part hereof.
2. The budget is hereby amended and the Mayor is authorized to allocate such resources and funds necessary to implement this Agreement.
3. The City agrees to pay the PATTISON AREA VOLUNTEER FIRE DEPARTMENT INCORPORATED the sum of THIRTY THOUSAND AND NO/100 (\$30,000.00) DOLLARS.
4. The City Council has adopted this Ordinance and related matters in order to protect health, life, and property and to preserve the good government, order and security of the City of Pattison and its residents.

III.

This Ordinance shall take effect from and after the date of its passage and all Ordinances or portion of Ordinances heretofore passed in conflict with the terms hereof are specifically repealed.

IV.

If any provision, section, subsection, sentence, clause, phrase of this Ordinance, or the application of same to any person or set of circumstances is for any reason held to be unconstitutional, void or invalid, the validity of the remaining portions of this Ordinance or their application to other persons or sets of circumstances shall not be affected thereby, it being the intent of the City Council in adopting this Ordinance that no portion thereof or provision, or regulation contained herein, shall become inoperative or fail by reason of any unconstitutionality of any other portion hereof and all provisions of this Ordinance are declared to be severable for that purpose.
