CITY COUNCIL MINUTES FEBRUARY 7, 2017 MEETING

I. Call meeting to Order

A Council meeting of the Pattison City Council was called to order by Mayor Joe Garcia at 7:00 p.m. in the Royal ISD Administration Building, located at 3714 FM 359, Pattison, Texas 77466.

V. Consent Agenda

A motion was made by Councilmember Branch to approve the consent agenda as presented. It was seconded by Councilmember Buller. The motion passed unanimously.

VI. Business:

A. Discuss and possible action on opening proposals and hiring a CPA for the 2016 audit.

A motion was made by Councilmember Stokes and seconded by Councilmember Branch to open the proposals. The motion passed unanimously. Mayor Garcia opened the two proposals the city received.

A motion was made by Councilmember Stokes to hire Seidel Schroder for the 2016 city audit with costs not to exceed \$6250.00. It was seconded by Councilmember Branch. The motion passed. Councilmember Buller abstained.

B. Discussion and Possible action to approve hiring of engineer for proposed drainage and road resurfacing project.

City Attorney, Lora Lenzsch informed the members of the council that the city did not have to have and could not go out for bids for professional services only for qualifications and proposals.

A motion was made by Councilmember Branch to hire Jones/Carter for proposed drainage and road resurfacing project. It was seconded by Councilmember Stokes. The motion passed. Councilmember Buller abstained.

C. Discuss and possible action on maintenance and street repairs.

A motion was made by Councilmember Stokes to standardize all work orders for maintenance and repairs in the city. It was seconded by Councilmember Branch. The motion passed unanimously.

He stated that if the city had an active Planning Commission it would help the city in the future with grants. Mayor Garcia asked all members to look over the rules and this item will be put back on the agenda in the future.

G. Discuss and possible action on amending ordinance #77 building permits fees.

Mayor Garcia asked that this item be tabled.

H. Discuss and possible action on the city naming history for the website.

A motion was made by Councilmember Stokes to use the current history provided by the Texas Historical Society. It was seconded by Councilmember Buller. The motion passed unanimously.
