MARCH 20, 2018 REGULAR MEETING**

**Page 1.**

**I. Call meeting to Order**

A regular meeting of the Pattison City Council was called to order by Mayor Joe Garcia at 7:00 p.m. in the Royal ISD Administration Building, located at 3714 FM 359, Pattison, Texas 77466.

**IV. Citizens Comments – No action can be taken:**

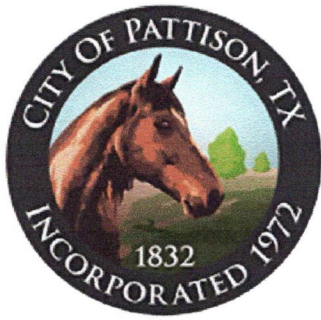
Citizens who desire to address the City Council will be limited to Three (3) Minutes.

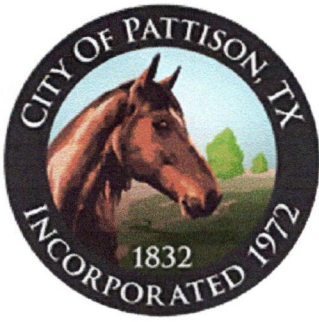
- 7. Council to discuss and take action on surplus culverts.**

- 10. Council to discuss and take action to approve payment #3 to American Parking Control.**


A motion was made by Councilmember MacCallum to approve 3rd payment to America Packing Control It was seconded by Councilmember Stokes. The motion passed unanimously.
