**10. Council to discuss and take action on city park improvement.**

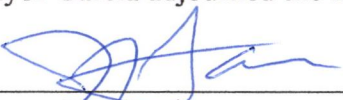

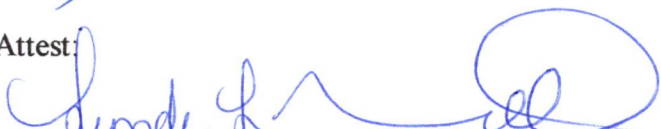
**11. Council to discuss upcoming town hall meeting.**
