



## RESOLUTION NO 2020 -009

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PATTISON, TEXAS, AUTHORIZING THE MAYOR TO EXECUTE AND SUBMIT AN AGREEMENT TO HOUSTON-GALVESTON AREA COUNCIL (H-GAC) WITH INCORPORATED EXHIBITS FOR A GRANT PROJECT TO HOLD TIRE, HOUSEHOLD WASTE AND E-SCRAP COLLECTION EVENT FOR SOUTH WALLER COUNTY RESIDENTS; REPEALING ALL WRITTEN OR ORAL AGREEMENTS, INCONSISTENT OR IN CONFLICT WITH THIS RESOLUTION.**

**WHEREAS**, the City Council met on the 4th day of August 2020 pursuant to the Texas Open Meetings Act; and

**WHEREAS**, the Mayor is hereby authorized to execute and submit to H-GAC an Agreement with incorporated exhibits for the grant project to hold Household Waste and E-Scrap collection events for the South Waller County Residents and City of Pattison.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PATTISON, TEXAS:**

SECTION 1. That the City Council does hereby approve the Mayor's execution and submittal of an Agreement to H-GAC with incorporated exhibits for the grant project to hold Tire, Household Waste and E-Scrap collection event for the South Waller County Residents and City of Pattison. Agreement with exhibits is set forth in Exhibit "A" attached hereto and made a part hereof.

SECTION 2. All resolutions and parts of resolutions, policies, rules, regulations, and practices, written or unwritten, of the City of Pattison inconsistent or in conflict herewith are hereby repealed.

SECTION 3. In the event any section, paragraph, subdivision, clause, phrase, provision, sentence, or part of this Resolution or the application of the same to any person or circumstance shall for any reason be adjudged invalid or held unconstitutional by a court of competent jurisdiction, it shall not affect, impair, or invalidate this Resolution as a whole or any part or provision hereof other than the part declared to be invalid or unconstitutional; and the City Council of the City of Pattison, Texas, declares that it would have passed each and every part of the same notwithstanding the omission of any such part thus declared to be invalid or unconstitutional, or whether there be one or more parts.
