Planning Commission members so appointed and approved may be reappointed, subject to approval by City Council, following each term of service. Vacancies for unexpired terms of any member whose position becomes vacant shall be filled by appointment by the Mayor, subject to approval by the City Council. Newly selected members shall be duly sworn and installed at the earliest possible City Council meeting.

Mayor made the recommendation to reappoint Rick MacDonald as the chair for the Planning Commission and to nominate Lyla Coulter and Debra Reyes to serve on the Planning Commission and expressed appreciation to Ken Coulter and Debleena Banjeri for serving on the Planning Commission who are both stepping down. Councilmember MacCallum made the motion to accept the nomination to reappoint Rick MacDonald and to appoint Lyla Coulter and Debra Reyes. Councilmember Kircher seconded the motion. The motion passed unanimously.

- 5. Council to discuss and take possible action on appointments the Parks Board.
 - Sec. 3. Appointment and term of office.

The Mayor shall nominate, and with the approval of the City Council, shall appoint and may remove at any time the members of the Parks Board. Each member shall serve for a term of two years; three (3) members to be appointed in every oddnumbered year and four (4) members to be appointed in every even numbered year. Parks Board members so appointed and approved may be reappointed, subject to approval by City Council, following each term of service. Vacancies for unexpired terms of any member whose position becomes vacant shall be filled by appointment by the Mayor, subject to approval by the City Council. Newly selected members shall be duly sworn and installed at the earliest possible City Council meeting.

Mayor made the recommendation to nominate Susan Cardiff to the Parks Board. Councilmember MacCallum made the motion to accept the nomination to appoint Susan Cardiff to the Parks Board. Councilmember Kircher seconded the motion. The motion passed unanimously.
