3. Council to discuss and take possible action regarding Resolution 2023-005 AUTHORIZING PROFESSIONAL SERVICE PROVIDER SELECTION FOR HAZARD MITIGATION ASSISTANCE PROGRAM(S) FUNDED THROUGH THE TEXAS DIVISION OF EMERGENCY MANAGEMENT (TDEM) AND/OR TEXAS WATER DEVELOPMENT BOARD (TWDB).

Councilmember Kircher made a motion to approve Resolution 2023-005 as stated above. Councilmember Kirby seconded the motion. The motion passed unanimously.

Councilmember Buller made a motion to contract with Seidel Schroeder for the FY 22-23 Audit. Councilmember Kircher seconded the motion. The motion passed unanimously.

10. Council to discuss and take possible action regarding Ordinance No. 168-2023 Amending the FY 22-23 Budget.

Councilmember Kirby made a motion to approve Ordinance No. 168-2023 as stated above with the corrections that were discussed. Councilmember Kircher seconded the motion. The motion passed unanimously.

11. Council to discuss and take possible action regarding the fee schedule.

Councilmember Buller made a motion to table this item. Councilmember Kirby seconded the motion. The motion passed unanimously.

12. Council to discuss and take possible action to schedule a Public Hearing for the FY 23-24 Budget.

Councilmember Buller made a motion to schedule a Public Hearing for the FY 23-24 Budget on September 28, 2023, at 6 p.m. Councilmember Kircher seconded the motion. The motion passed unanimously.

13. Council to discuss and take possible action authorizing participation in TexPool an Investment Service for Public Funds.

Councilmember Buller made a motion to invest \$250,000.00 in TexPool an Investment Service for Public Funds. Councilmember Kirby seconded the motion. The motion passed unanimously.

14. Council to discuss and take possible action regarding the Oak Meadows drainage project.

Mayor Garcia made a recommendation to approve the Oak Meadows drainage project not to exceed \$8,000.00, contingent on Oak Meadows HOA approval to pay half, to authorize Blue Sky as the contractor, and the City Engineer to supervise the project. Councilmember Kircher made the motion as stated above. Councilmember Coulter seconded the motion. Councilmember Kirby opened the discussion concerning other areas of Oak Meadows being addressed. Blue Jay area and the 7th Street & Ave I are two areas that have been brought to the council's attention to address. The motion passed with 3 voting yes, Councilmember Buller opposed.

15. Council to discuss and take possible action regarding drainage project for 7th Street and Ave I.

Mayor Garcia made the recommendation to authorize drainage project for 7th Street and Ave I not to exceed \$6,500.00, authorizing Blue Sky as the contractor and the City Engineer to supervise the project. Councilmember Kirby made a motion to authorize the drainage project as stated above. Councilmember Buller seconded the motion. The motion passed unanimously.

16. Council to discuss and take possible action regarding City Hall Renovation.
