ORDINANCE NO. #169-2023

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF PATTISON, TEXAS, AMENDING THE BUDGET OF THE CITY OF PATTISON, TEXAS, FOR THE FISCAL YEAR 2022-2023; PROVIDING FOR SEVERABILITY; AND CONTAINING OTHER PROVISIONS RELATING TO THE SUBJECT.

WHEREAS, the City of Pattison, Texas Fiscal Year 2022-2023 Budget was adopted within the time and in the manner required by State law; and

WHEREAS, the City Council hereby finds and determines that certain budget amendments are required to be adopted for the Fiscal Year 2022-2023 Budget; and

WHEREAS, the City Council finds and determines that the proposed changes in the budget are for municipal purposes, and that the amendments of the budget are a matter of public necessity requiring adoption of the amendments to the budget at this time;

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE

CITY OF PATTISON, TEXAS:

Section 1. The facts and matters set forth in the preamble of this ordinance are found to be true and correct and incorporated herein for all purposes.

Section 2. The City of Pattison, Texas Fiscal Year 2022-2023 Budget is hereby amended as shown on Exhibit "A" which is attached hereto and incorporated herein for all purposes. This amendment to the Budget of the City of Pattison, Texas for the Fiscal Year 2022-2023 shall be attached to and made a part of the Original Budget by the City Secretary and filed as required by State Law.
