ORDINANCE 176-2024

AN ORDINANCE OF THE CITY OF PATTISON, TEXAS, ESTABLISHING A MASTER FEE SCHEDULE; PROVIDING FOR REPEAL; PROVIDING FOR SEVERABILITY; PROVIDING A PENALTY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Council of the City of Pattison, Texas ("City") finds that establishing a Master Fee Schedule will be for the good of the government and ensures that the City is capturing reasonable and appropriate revenues; and

WHEREAS, a Master Fee Schedule provides the public and City staff with a consolidated placement for most City fees;

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PATTISON, TEXAS:

Section 1. The facts and recitations set forth in the preamble of this Ordinance are found to be true and correct.

Section 2. The City of Pattison, Texas, adopts the Master Fee Schedule as provided for in Exhibit "A" which is attached hereto and incorporated herein for all purposes.

Section 3. Repeal. Ordinance No. 152 and all Ordinances or parts of Ordinances in conflict herewith are repealed.

<u>Section 4</u>. Severability. In the event any section, paragraph, subdivision, clause, phrase, provision, sentence, or part of this Ordinance or the application of the same to any person or circumstance shall for any reason be adjudged invalid or held unconstitutional by a court of competent jurisdiction, it shall not affect, impair, or invalidate the Ordinance as a whole or any part of provision hereof other than the part declared to be invalid or unconstitutional; and the City Council of the City of Pattison, Texas, declares that it would have passed each and every part of the same notwithstanding the omission of any such part thus declared to be invalid or unconstitutional, whether there be one of more parts.

<u>Section 5.</u> Penalty. Any person who violates or causes, allows, or permits another to violate any provision of this Ordinance, rule, or police regulation of the city shall be deemed guilty of a misdemeanor and, upon conviction thereof, shall be punished by a fine or penalty not to exceed five hundred dollars (\$500.00). If such rule, ordinance, or police regulations governs fire safety, or public health and sanitation, other than the dumping of refuse, the fine or penalty shall not exceed two thousand dollars (\$2,000.00). If such rule, ordinance, or police regulation governs the dumping of refuse, the fine or penalty shall not exceed four thousand dollars (\$4,000.00). Each occurrence of any violation of this ordinance, rule, or police regulation shall constitute a separate offense. Each day on which any such violation of this ordinance, rule, or police regulation occurs shall constitute a separate offense.

<u>Section 6.</u> Effective Date. This Ordinance shall become effective immediately and enforceable when published as required by law.

City Inspection fees for water, sanitary sewer, storm sewer, drainage, levee, and street improvements shall be:

- (a) One percent (1%) of actual construction cost on Projects of \$10,000.00 or less.
- (b) One hundred dollars (\$100.00) plus three fourths of one percent (3/4 of 1%) of actual construction cost on Projects over \$10,000.00 but less than \$50,000.00.
- (c) Four hundred dollars (\$400.00) plus one-half percent (1/2 of 1%) of actual construction costs on Projects \$50,000.00 and higher.
