AN ORDINANCE OF THE CITY OF PATTISON, TEXAS, CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE CITY'S GENERAL ELECTION HELD MAY 4, 2024.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PATTISON, TEXAS:

That said election was duly called; that notice of said election was given in accordance with law and is this Ordinance declares that Daphney Kirby was duly elected as Mayor, Joe Garcia was duly elected as Council Position 1, and Frank J. Cobio was duly elected as Council Position 2.

It is further found and determined that in accordance with the order of this governing body that the City Secretary posted written notice of the date, place and subject of this meeting on the bulletin board located at City Hall, a place convenient to the public, and said notice having been so posted and remaining posted continuously for at least 72 hours preceding the date of this meeting. A copy of the return of said posting shall be attached to the minutes of this meeting and shall be made a part thereof for all intents and purposes.
