2. City Engineer Craig Kalkomey to give update on drainage projects (Ave H, Ave I, 6<sup>th</sup>, and 7<sup>th</sup> Streets).

City Engineer Kalkomey gave an update on drainage projects for Ave H, Ave I, 6<sup>th</sup> and 7<sup>th</sup> Streets. The original proposal was for half the block, the new proposal has been expanded to survey the entire block and the proposal will be higher than presented at last meeting (\$3,100.00) to cover the entire block in the amount of \$6,500.00. He also stated that the city has received notice from TDA that it is looking favorable for the CDBG grant. That could take a while to receive the grant. The options are to do the survey now and that would free up the grant funds to be used for construction. With the completed survey the project can be broken into phases. The survey will be helpful for the CDBG grant. The project can be broken into phases as needed.
