The following steps must be completed, and the items must be submitted for the application to be deemed complete and processed:

		Payment of all applicable fees
		Tax Certificates
		Transmittal Letter
		Current title commitment of specific tract of land
		Resolution of any contingency items recommended by the Commission
		Performance bonds, letter of credit for the cost of the public improvements, or assurance of completion of the public improvements
		Final Plat and construction plans (or as a minimum requirement, the final utility layout showing the sizes and depths of all utilities as well as street widths)
		Final plat must be prepared by a registered professional land surveyor
		Submit Plat electronically (AutoCAD, .DWG, or compatible .DXF file) along with ten (10) printed hard copies on legible format on a good grade blue line or black line paper size 22" x 34" and at a scale no larger than 1" = 100'
		The final plat cannot be submitted for City Council approval until detailed engineering plans have been submitted for approval by the City Engineer
